



Fiscal Alliance Foundation Transportation and Climate Initiative (TCI) Poll 712 Likely Voters January 14-19, 2020 MOE +/- 3.7%

1) The Governor wants Massachusetts to join the Transportation and Climate Initiative (TCI), a regional collaboration of 11 states that seek to improve transportation and reduce carbon emissions from the transportation sector by increasing the costs of gasoline and diesel fuel. Do you support or oppose Massachusetts joining TCI?
